ESTATE DUTY ENACTMENT 1941

APPOINTMENT AND REVOCATION OF APPOINTMENT
OF COLLECTOR OF ESTATE DUTY AND ASSISTANT COLLECTOR OF ESTATE DUTY

IN exercise of the powers conferred by section 52 of the Estate Duty Enactment 1941 [*F.M.S. 7/1941*], and read together with subsection 46(2) of the Finance Act 1992 [*Act 476*], the Yang di-Pertuan Agong appoints the persons named in the First Schedule to be the Collector of Estate Duty and Assistant Collector of Estate Duty with effect from the date of the *Gazette*.

Revocation

2. The appointment of the persons named in column (1) as published in the *Gazette* in column (2) of the Second Schedule is revoked with effect from the date of the *Gazette*.
