NOTICE OF EXEMPTION UNDER SUBSECTION 73(1)
(EAST WEST ONE PLANTATIONS BERHAD)

IN exercise of the powers conferred under subsection 73(1) of the Interest Schemes Act 2016 [Act 778], the Minister exempts East West One Plantations Berhad from complying with section 47 of the Act, in relation to the interests in the trust deed for the East West Planter's Scheme 1, with effect from 15 August 2019 to 15 August 2021 subject to the condition that East West One Plantations Berhad shall comply with any guidelines in relation to interest schemes issued by the Companies Commission of Malaysia from time to time.
