PEMBERITAHUAN DI BAWAH SEKSYEN 60

PADA menjalankan kuasa yang diberikan oleh seksyen 60 Akta Senjata 1960 [*Akta 206*], Menteri mengecualikan Pengarah DSA Exhibition and Conference Sdn. Bhd. daripada—

- (a) pemakaian subseksyen 3(2) Akta berkenaan dengan senjata dan amunisi yang dimaksudkan semata-mata bagi maksud pameran di *Defence Services Asia 2022 (DSA 2022)* dan *National Security Asia 2022 (NATSEC Asia 2022)* dengan syarat bahawa lesen senjata yang diberikan kepada Pengarah DSA Exhibition and Conference Sdn. Bhd. berhubung dengan senjata dan amunisi itu berkuat kuasa; dan
- (b) pemakaian perenggan 5(1)(a) dan (b) Akta berkenaan dengan senjata dan amunisi yang dimaksudkan semata-mata bagi maksud pameran di *Defence Services Asia 2022 (DSA 2022)* dan *National Security Asia 2022 (NATSEC Asia 2022)*.

2. Pemberitahuan ini berkuat kuasa mulai 1 Mac 2022 hingga 1 Mei 2022.

ARMS ACT 1960

NOTIFICATION UNDER SECTION 60

IN exercise of the powers conferred by section 60 of the Arms Act 1960 [*Act 206*], the Minister exempts the Director of DSA Exhibition and Conference Sdn. Bhd. from—

- (a) the application of subsection 3(2) of the Act in respect of arms and ammunition intended solely for the purpose of display at the Defence Services Asia 2022 (DSA 2022) and National Security Asia 2022 (NATSEC Asia 2022) provided that the arms licence granted to the Director of DSA Exhibition and Conference Sdn. Bhd. in respect of the arms and ammunition is in force; and
- (b) the application of paragraphs 5(1)(a) and (b) of the Act in respect of arms and ammunition intended solely for the purpose of display at the Defence Services Asia 2022 (DSA 2022) and National Security Asia 2022 (NATSEC Asia 2022).

2. This Notification has effect from 1 March 2022 to 1 May 2022.
