NATIONAL WAGES CONSULTATIVE COUNCIL ACT 2011

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBER
OF THE NATIONAL WAGES CONSULTATIVE COUNCIL

IN exercise of the powers conferred by paragraph 5(1)(d) of the National Wages Consultative Council Act 2011 [Act 732], the Minister appoints the public officer holding the office of the Director, Sabah State Economic Planning Unit, Sabah Chief Minister's Department as a member of the Council with effect from 7 October 2021.

Revocation of appointment

2. The appointment of the Permanent Secretary, Ministry of Education and Innovation, State of Sabah as a member of the Council from amongst the public officers as in the notification of Appointment and Revocation of Appointment of Members of the National Wages Consultative Council [P.U. (B) 470/2017] published in the *Gazette* on 11 October 2017 read together with the notification of Change of Title of Office of Member of the National Wages Consultative Council [P.U. (B) 199/2020] published in the *Gazette* on 14 April 2020 is revoked with effect from 7 October 2021.
