PADA menjalankan kuasa yang diberikan oleh subseksyen 4(1) dibaca bersama subseksyen 1(8) Akta Pengurusan Strata 2013 [*Akta 757*], Menteri Wilayah Persekutuan melantik Fadzilah bin Mahmud @ Mamud sebagai Timbalan Pesuruhjaya Bangunan bagi Wilayah Persekutuan Labuan berkuat kuasa mulai 29 Mac 2021.

Pembatalan pelantikan

STRATA MANAGEMENT ACT 2013

APPOINTMENT OF DEPUTY COMMISSIONER OF BUILDINGS
AND REVOCATION OF APPOINTMENT OF DEPUTY COMMISSIONER
OF BUILDINGS AND OFFICER FOR THE FEDERAL TERRITORY OF LABUAN

IN exercise of the powers conferred by subsection 4(1) read together with subsection 1(8) of the Strata Management Act 2013 [*Act 757*], the Minister of Federal Territories appoints Fadzilah bin Mahmud @ Mamud as the Deputy Commissioner of Buildings for the Federal Territory of Labuan with effect from 29 March 2021.

Revocation of appointment

2. The appointment of the persons named in column (1) of the Schedule to hold the posts as specified in column (2) by the notification of the Appointment

of Commissioner of Buildings, Deputy Commissioners of Buildings and Officers for the Federal Territory of Labuan [*P.U. (B) 565/2017*] published in the *Gazette* on 5 December 2017 is revoked with effect from the dates specified in column (3).
