MALAYSIAN PEPPER BOARD ACT 2006

APPOINTMENT AND REVOCATION OF APPOINTMENT
OF ALTERNATE MEMBER OF THE BOARD

IN exercise of the powers conferred by subsection 8(1) of the Malaysian Pepper Board Act 2006 [*Act 656*], the Minister has appointed Encik Mohd Faisal bin Wahid @ Mohamad as an alternate member of the Board under paragraph 6(b) of the Act for the period from 15 July 2021 to 31 December 2022.

Revocation of appointment

The appointment of Puan Firna Azura Ekaputri binti Marzuki as an alternate member of the Board in the notification of Appointment and Revocation of Appointment of Members and Alternate Members of the Board [*P.U.
