(b) dalam butiran 3, dengan memasukkan selepas perkataan “Gas Cecair Petroleum” perkataan “(kecuali di Negeri Sarawak)”.

PETROLEUM DEVELOPMENT ACT 1974

NOTIFICATION OF EXEMPTION (AMENDMENT) 2021

IN exercise of the powers conferred by subsection 6(6) of the Petroleum Development Act 1974 [*Act 144*], the Prime Minister makes the following notification:

Citation and commencement

1. (1) This notification may be cited as the **Notification of Exemption (Amendment) 2021**.

(2) This Notification comes into operation on 1 June 2021.

Amendment of Schedule

2. The Schedule to the Notification of Exemption [*P.U. (A) 86/1982*] is amended in paragraph II—

(a) in item 2, by inserting after the words “Natural Gas” the words “(except in the State of Sarawak)”; and

(b) in item 3, by inserting after the words “Liquefied Petroleum Gas” the words “(except in the State of Sarawak)”.
