PADA menjalankan kuasa yang diberikan oleh subseksyen 4(1) Akta Pengurusan Strata 2013 [*Akta 757*] dibaca bersama subseksyen 1(8), Menteri Wilayah Persekutuan melantik orang yang dinamakan dalam ruang (1) Jadual untuk memegang jawatan yang dinyatakan dalam ruang (2) berkuat kuasa mulai tarikh yang dinyatakan dalam ruang (3).

Pembatalan pelantikan

Pelantikan Datuk Dr. Aminuddin bin Hassim sebagai Pesuruhjaya Bangunan bagi Wilayah Persekutuan Putrajaya dalam pemberitahuan Pelantikan Pesuruhjaya Bangunan dan Timbalan Pesuruhjaya Bangunan bagi Wilayah Persekutuan Putrajaya [*P.U. (B) 136/2019*] yang disiarkan dalam *Warta* pada 13 Mac 2019 dibatalkan berkuat kuasa mulai 1 Oktober 2020.

STRATA MANAGEMENT ACT 2013

APPOINTMENT OF COMMISSIONER OF BUILDINGS AND DEPUTY COMMISSIONER OF
BUILDINGS AND REVOCATION OF APPOINTMENT OF COMMISSIONER OF BUILDINGS
FOR THE FEDERAL TERRITORY OF PUTRAJAYA

IN exercise of the powers conferred by subsection 4(1) of the Strata Management Act 2013 [*Act 757*] read together with subsection 1(8), the Minister of Federal Territories appoints the persons named in column (1) of the Schedule to hold the posts specified in column (2) with effect from the dates specified in column (3).

Revocation of appointment

2. The appointment of Datuk Dr. Aminuddin bin Hassim as the Commissioner of Buildings for the Federal Territory of Putrajaya in the notification of Appointment of Commissioner of Buildings and Deputy Commissioner of Buildings for the

Federal Territory of Putrajaya [*P.U. (B) 136/2019*] published in the *Gazette* on 13 March 2019 is revoked with effect from 1 October 2020.
