2. Pelantikan Tuan Ahmad bin Tuan Besar sebagai anggota silih ganti Lembaga yang disiarkan dalam pemberitahuan Pelantikan Anggota dan Anggota Silih Ganti Lembaga [*P.U. (B) 2/2021*] dalam *Warta* pada 5 Januari 2021 dibatalkan berkuat kuasa mulai 1 Ogos 2020.

MALAYSIAN TIMBER INDUSTRY BOARD (INCORPORATION) ACT 1973

APPOINTMENT AND REVOCATION OF APPOINTMENT
OF ALTERNATE MEMBER OF THE BOARD

IN exercise of the powers conferred by subsection 7(1) of the Malaysian Timber Industry Board (Incorporation) Act 1973 [*Act 105*], the Minister has appointed Dato' Chung King Tong as an alternate member of the Board under paragraph 4(1)(g) of the Act for the period from 1 August 2020 to 31 December 2021.

Revocation of appointment

2. The appointment of Tuan Ahmad bin Tuan Besar as an alternate member of the Board published in the notification of Appointment of Members and Alternate Members of the Board [*P.U. (B) 2/2021*] in the *Gazette* on 5 January 2021 is revoked with effect from 1 August 2020.
