## AKTA LEMBAGA PERINDUSTRIAN KAYU MALAYSIA (PEMERBADANAN) 1973

PELANTIKAN DAN PEMBATALAN PELANTIKAN ANGGOTA DAN  
ANGGOTA SILIH GANTI LEMBAGA

PADA menjalankan kuasa yang diberikan oleh subseksyen 4(1) dan 7(1) Akta Lembaga Perindustrian Kayu Malaysia (Pemerbadanan) 1973 [*Akta 105*], Menteri telah melantik orang yang dinamakan dalam ruang (2) dan (4) Jadual Pertama sebagai anggota dan anggota silih ganti Lembaga di bawah perenggan yang dinyatakan dalam ruang (1) bagi tempoh yang masing-masing dinyatakan dalam ruang (3) dan (5).

**Pembatalan pelantikan**

2. ## MALAYSIAN TIMBER INDUSTRY BOARD (INCORPORATION) ACT 1973
