MALAYSIAN TIMBER INDUSTRY BOARD (INCORPORATION) ACT 1973

APPOINTMENT AND REVOCATION OF APPOINTMENT
OF DEPUTY DIRECTOR GENERAL OF THE BOARD

IN exercise of the powers conferred by subsection 9(2) of the Malaysian Timber Industry Board (Incorporation) Act 1973 [*Act 105*], the Board, with the consent of the Minister, has appointed Mahpar bin Atan as the Deputy Director General of the Board with effect from 1 July 2020.

Revocation of appointment

The appointment of Mohd Kheiruddin bin Mohd Rani as the Deputy Director General of the Board as notified in the Notification of Appointment and Revocation of Appointment of Deputy Director General of the Board [*Gazette Notification No. 12716/2019*] published on 24 July 2019 is revoked with effect from 1 September 2019.
