IN exercise of the powers conferred by section 11 of the Rubber Industry Smallholders Development Authority Act 1972 [*Act 85*], the Minister has appointed Abdullah bin Zainal @ Deraman as the Director General of the Rubber Industry Smallholders Development Authority with effect from 17 June 2020.
