APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBERS
OF THE ADVISORY BOARD

IN exercise of the powers conferred by section 7 of the Federal Capital Act 1960 [*Act 190*] and pursuant to paragraph 2(c) of the Advisory Board of the City of Kuala Lumpur Regulations 1989 [*P.U.
