PADA menjalankan kuasa yang diberikan oleh subperaturan 3(2) dan 3(8) Peraturan-Peraturan Kawalan Dadah dan Kosmetik 1984 [*P.U. (A) 223/1984*], Menteri telah melantik orang yang dinamakan dalam ruang (1) Jadual sebagai anggota Pihak Berkuasa Kawalan Dadah di bawah perenggan 3(2)(d) bagi tempoh tiga tahun berkuat kuasa mulai 1 Januari 2020 dan orang yang dinamakan dalam ruang (2) sebagai anggota silih ganti mereka masing-masing.

Pembatalan pelantikan

Pelantikan Prof. Madya Dr. Mohd Makmor Bakry sebagai anggota Pihak Berkuasa Kawalan Dadah dan Dr. Norazrina Azmi sebagai anggota silih gantinya dalam pemberitahuan Pelantikan Anggota dan Anggota Silih Ganti Pihak Berkuasa [*P.U. (B) 389/2018*] yang disiarkan dalam *Warta* pada 17 Julai 2018 dibatalkan berkuat kuasa mulai 1 Januari 2020.

CONTROL OF DRUGS AND COSMETICS REGULATIONS 1984

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBERS AND ALTERNATE
MEMBERS OF THE DRUG CONTROL AUTHORITY

IN exercise of the powers conferred by subregulations 3(2) and 3(8) of the Control of Drugs and Cosmetics Regulations 1984 [*P.U. (A) 223/1984*], the Minister has appointed the persons named in column (1) of the Schedule as members of the Drug Control Authority under paragraph 3(2)(d) for a period of three years with effect from 1 January 2020 and the persons named in column (2) as their alternate members respectively.

Revocation of appointment

2. The appointment of Prof. Madya Dr. Mohd Makmor Bakry as a member of the Drug Control Authority and Dr. Norazrina Azmi as his alternate member in the notification of Appointment of Members and Alternate Members of the Authority [P.U. (B) 389/2018] as published in the *Gazette* on 17 July 2018 are revoked with effect from 1 January 2020.
