NATIONAL WAGES CONSULTATIVE COUNCIL ACT 2011

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBER OF  
THE NATIONAL WAGES CONSULTATIVE COUNCIL

In exercise of the powers conferred by paragraph 5(1)(d) of the National Wages Consultative Council Act 2011 [Act 732], the Minister appoints the public officer holding the office of the Director of the National Budget Office, Ministry of Finance as a member of the National Wages Consultative Council.

**Revocation of appointment**

2. The appointment of the Deputy Secretary General (Policy), Ministry of Finance as the member of the National Wages Consultative Council as specified in the notification of the Appointment and Revocation of Appointment of Members of the National Wages Consultative Council [*P.U. (B) 470/2017*] published in the *Gazette* on 11 October 2017 is revoked.
