“230. (1) The fees of the directors, and any benefits payable to the directors including any compensation for loss of employment of a director or former director—

(a) of a public company; or

(b) of a listed company and its subsidiaries,

shall be approved at a general meeting.”;

- (s) dalam perenggan 2 Jadual Keenam, gantikan perkataan “manager ’s” dengan perkataan “manager’s”.

- (f) in paragraph 177(1)(f), substitute for the word “metting” the word “meeting”;
- (g) in paragraph 196(4)(a), substitute for the words “b y” the word “by”;
- (h) in subsection 207(2), substitute for the words “repre entation” the word “representation”;
- (i) in subsection 226(2), substitute for the words “a ny” the word “any”;

(j) substitute for subsection 230(1) the following subsection:

“230. (1) The fees of the directors, and any benefits payable to the directors including any compensation for loss of employment of a director or former director—

(a) of a public company; or

(b) of a listed company and its subsidiaries,

shall be approved at a general meeting.”;

(k) in paragraph 284(a)—

(i) substitute for the words “circums tances” the word “circumstances”;
and

(ii) substitute for the words “w ith” the word “with”;

(l) in subsection 303(7)—

(i) substitute for the words “A ny” the word “Any”; and

(ii) substitute for the words “expens es” the word “expenses”;

(m) in paragraph 322(4)(a), substitute for the words “news paper” the word “newspaper”;

(n) in paragraph 339(6)(a), substitute for the words “provis ion” the word “provision”;

(o) in paragraph 346(2)(a), substitute for the word “actor” the words “act or”;

- (p) in subsection 457(3), substitute for the words “member ’s” the word “member’s”;
- (q) in subsection 575(4), substitute for the word “ontain” the word “obtain”;
- (r) in subsection 618(10), substitute for the words “Registrar ’s” the word “Registrar’s”; and
- (s) in paragraph 2 of the Sixth Schedule, substitute for the words “manager ’s” the word “manager’s”.
