HIGHWAY AUTHORITY MALAYSIA (INCORPORATION) ACT 1980

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBER
AND ALTERNATE MEMBER OF THE AUTHORITY

IN exercise of the powers conferred by paragraph 4(1)(c) and subsection 5(1) of the Highway Authority Malaysia (Incorporation) Act 1980 [*Act 231*], the Minister has appointed Dato' Razali bin Mohamad as a member of the Authority and Puan Farzana binti Muhamad as his alternate member for the period from 30 October 2019 to 29 October 2021.
