STRATA MANAGEMENT ACT 2013

APPOINTMENT AND REVOCATION OF APPOINTMENT OF
COMMISSIONER OF BUILDINGS FOR THE FEDERAL TERRITORY OF LABUAN

IN exercise of the powers conferred by subsection 4(1) of the Strata Management Act 2013 [*Act 757*] read together with subsection 1(8), the Minister of Federal Territories appoints Dr. Fary Akmal binti Osman as the Commissioner of Buildings for the Federal Territory of Labuan with effect from 10 July 2019.

Revocation of appointment

2. The appointment of Datuk Azhar bin Ahmad as the Commissioner of Buildings for the Federal Territory of Labuan as published in P.U. (B) 565/2017 on 5 December 2017 is revoked with effect from 25 February 2019.
