NOTICE OF COMPLETION OF ASSUMPTION OF CONTROL
(KOPERASI GURU-GURU DTC MALAYSIA BERHAD)

WHEREAS, by the Co-operative Societies (Assumption of Control) (Appointment) Order 2016 [*P.U. (A) 80/2016*] published on 29 March 2016, the Malaysia Co-operative Societies Commission has appointed Mohd Shihabuddin bin Mohd Yazid to assume control of the whole of the property, business, activities and affairs of the Koperasi Guru-Guru DTC Malaysia Berhad, and carry on the whole of its business, activities and affairs with effect from 30 March 2016 to 29 March 2018 or until a Board is elected under the by-laws of the co-operative society, whichever is earlier:
