CONTROL OF DRUGS AND COSMETICS REGULATIONS 1984

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBER AND
ALTERNATE MEMBER OF THE DRUG CONTROL AUTHORITY

PURSUANT TO subregulation 3(8) of the Control of Drugs and Cosmetics Regulations 1984 [*P.U.
