PADA menjalankan kuasa yang diberikan oleh subseksyen 3(4) Akta Pengangkutan Jalan 1987 [*Akta 333*], Datuk Bandar Kuala Lumpur telah melantik—

- (a) orang dalam perkhidmatan Bandaraya Kuala Lumpur yang dinamakan dalam Jadual Pertama untuk menjadi warden lalu lintas berkuat kuasa mulai 26 Februari 2019; dan
- (b) orang dalam perkhidmatan Bandaraya Kuala Lumpur yang dinamakan dalam Jadual Kedua untuk menjadi warden lalu lintas berkuat kuasa mulai 1 Mac 2019.

APPOINTMENT OF TRAFFIC WARDEN

IN exercise of the powers conferred by subsection 3(4) of the Road Transport Act 1987 [*Act 333*], the Commissioner of the City of Kuala Lumpur has appointed—

- (a) the persons in the service of the City of Kuala Lumpur named in the First Schedule to be traffic wardens with effect from 26 February 2019; and
- (b) the persons in the service of the City of Kuala Lumpur named in the Second Schedule to be traffic wardens with effect from 1 March 2019.
