 - (iv) “Seri Maju Trading Sdn. Bhd.”;
 - (v) “Sitiawan Forex Sdn. Bhd.”;
 - (vi) “Taipan Boulevard Sdn. Bhd.”; dan
 - (vii) “Tik FX Malaysia Sdn. Bhd. (dahulunya dikenali sebagai/*formerly known as* Overseas Remittance Sdn. Bhd.)”;

- (d) dengan memasukkan selepas perkataan “Top Enterprise Capital Sdn. Bhd.”, perkataan “Tranglo Sdn. Bhd.”; dan
- (e) dengan memotong perkataan “Xinren Capital Sdn. Bhd.”.

MONEY SERVICES BUSINESS ACT 2011
AMENDMENT TO THE LIST OF LICENSEES

- (vi) “Taipan Boulevard Sdn. Bhd.”; and
- (vii) “Tik FX Malaysia Sdn. Bhd. (dahulunya dikenali sebagai/
formerly known as Overseas Remittance Sdn. Bhd.);
- (d) by inserting after the words “Top Enterprise Capital Sdn. Bhd.” the words
“Tranglo Sdn. Bhd.”; and
- (e) by deleting the words “Xinren Capital Sdn. Bhd.”.
