PERIZABAN TANAH BAGI MAKSUD AWAM

Jawatankuasa Kerja Tanah Wilayah Persekutuan Kuala Lumpur, pada menjalankan kuasa di bawah subseksyen 62(1) Kanun Tanah Negara [Akta 56/1965], yang diwakilkan kepada Jawatankuasa Kerja Tanah Wilayah Persekutuan Kuala Lumpur melalui pemberitahuan dalam Perwakilan Kuasa di bawah Seksyen 13 [P.U.(B) 108/2003] oleh Kerajaan Persekutuan yang kepadanya diberikan kuasa di bawah Kanun Tanah Negara oleh Perintah Wilayah Persekutuan (Pengubahsuaian Kanun Tanah Negara) 1974 [P.U.(A) 56/1974]—

- (a) merizabkan tanah yang diperihalkan dalam Jadual bagi maksud awam untuk Tokong Kwan Tee; dan

NATIONAL LAND CODE

RESERVATION OF LAND FOR PUBLIC PURPOSE

The Land Executive Committee of the Federal Territory of Kuala Lumpur, in exercise of the powers under subsection 62(1) of the National Land Code [Act 56/1965], delegated to the Land Executive Committee of the Federal Territory of Kuala Lumpur by notification in the Delegation of Powers under Section 13 [P.U.(B) 108/2003] by the Government of the Federation upon whom the powers under the National Land Code had been conferred by the Federal Territory (Modification of National Land Code) Order 1974 [P.U.(A) 56/1974]—

- (a) has reserved the land described in the Schedule for a public purpose of Kwan Tee Temple; and
- (b) has designated that Director of Lands and Mines of Federal Territory of Kuala Lumpur shall have control of the reserved land.
