MALAYSIAN COCOA BOARD (INCORPORATION) ACT 1988

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBERS AND  
ALTERNATE MEMBERS OF THE BOARD

IN exercise of the powers conferred by section 3B and subsection 5(1) of the Malaysian Cocoa Board (Incorporation) Act 1988 [*Act 343*], the Minister has appointed the persons named in columns (2) and (4) of the First Schedule as members and alternate members of the Board under the provision specified in column (1) for the period specified in columns (3) and (5) respectively.
