BERIKUTAN penyiaran Notis Pemulaan Kajian Semula Dipercepat Duti Anti-Lambakan mengenai Import *Electrolytic Tinplate* yang berasal atau diekспорт dari Zhongshan Shunwei Import and Export Co., Ltd dari Republik Rakyat China pada 30 Mac 2018 [P.U. (B) 156/2018], Kerajaan telah membuat suatu penentuan kajian semula dipercepat muktamad afirmatif terhadap kajian semula dipercepat menurut subseksyen 28B(1) Akta bahawa suatu margin lambakan wujud mengenai import *electrolytic tinplate* yang dikelaskan di bawah Nombor Kod Sistem yang Diharmonikan (Kod H.S.) 7210.12.9000 (“dagangan subjek”) yang berasal atau diekспорт dari Zhongshan Shunwei Import and Export Co., Ltd dari Republik Rakyat China ke dalam Malaysia.

Sebab bagi penentuan muktamad afirmatif

1. Sebab bagi penentuan kajian semula dipercepat muktamad afirmatif adalah seperti yang berikut:

- (a) harga eksport dagangan subjek adalah kurang daripada nilai normalnya; dan
- (b) margin lambakan sebanyak 7.38% didapati wujud melalui kegiatan lambakan oleh pengeksport iaitu Zhongshan Shunwei Import and Export Co., Ltd dari Republik Rakyat China.

2. Duti anti-lambakan yang akan dikenakan adalah sebagaimana yang dinyatakan dalam Jadual.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

NOTICE OF AFFIRMATIVE FINAL EXPEDITED REVIEW DETERMINATION OF THE ANTI-DUMPING DUTIES WITH REGARD TO THE IMPORTS OF ELECTROLYTIC TINPLATE ORIGINATING IN OR EXPORTED FROM ZHONGSHAN SHUNWEI IMPORT AND EXPORT CO., LTD FROM THE PEOPLE'S REPUBLIC OF CHINA

(NSR 01/18)

FOLLOWING the publication of the Notice of Initiation of Expedited Review of the Anti-Dumping Duties with respect to the imports of Electrolytic Tinplate originating in or exported from Zhongshan Shunwei Import and Export Co., Ltd from the People's Republic of China on 30 March 2018 [*P.U. (B) 156/2018*], the Government has made an affirmative final expedited review determination pursuant to subsection 28B(1) of the Act that a dumping margin exists with regard to the imports of electrolytic tinplate classified under Harmonised System Code (H.S. Code) 7210.12.9000 ("the subject merchandise") originating in or exported from Zhongshan Shunwei Import and Export Co., Ltd from People's Republic of China into Malaysia.

Reasons for affirmative final determination

1. The reasons for the affirmative final expedited review determination are as follows:
 - (a) the export price of the subject merchandise is lesser than its normal value;
and
 - (b) the dumping margin of 7.38% was established through the dumping activities by the exporter which is Zhongshan Shunwei Import and Export Co., Ltd from the People's Republic of China.

Anti-dumping duties

2. The anti-dumping duties to be imposed shall be as specified in the Schedule.

Period of imposition of anti-dumping duties

3. The anti-dumping duties imposed in paragraph 2 shall apply from 26 July 2018 to 15 November 2018.
