**NOTICE TO HOLD A GENERAL ELECTION TO
THE LEGISLATIVE ASSEMBLY OF THE STATE OF SABAH**

WHEREAS the Legislative Assembly of the State of Sabah has become vacant in consequence of its dissolution on 7 April 2018 by the Yang Di-Pertua of Sabah.

TAKE NOTICE that the Election Commission has issued election writs on 11 April 2018 to the returning officers of the State Constituencies of Sabah specified in the Schedule hereto and that the day of nomination in respect of each State Constituency shall be 28 April 2018 and that in the event of a contested election in any of such Constituencies, the advance polling day shall be 5 May 2018 and the polling day shall be 9 May 2018.
