## AKTA PERHUTANAN NEGARA 1984

PELANTIKAN DAN PEMBATALAN PELANTIKAN PENGARAH PERHUTANAN,  
TIMBALAN PENGARAH PERHUTANAN, PENOLONG PENGARAH PERHUTANAN  
DAN PENGAWAS HUTAN

PADA menjalankan kuasa yang diberikan oleh subseksyen 3(1) Akta Perhutanan Negara 1984 [*Akta 313*] dan menurut Jadual Kelima, Menteri telah melantik orang yang dinamakan dalam ruang (1) Jadual untuk memegang jawatan yang dinyatakan dalam ruang (2) bagi Wilayah Persekutuan Kuala Lumpur berkuat kuasa mulai tarikh yang dinyatakan dalam ruang (3) dan bagi tempoh mereka berkhidmat selepas tarikh itu dengan Jabatan Perhutanan Wilayah Persekutuan Kuala Lumpur.

**Pembatalan pelantikan**

2. Pelantikan Ag Shaffie bin Ag Ahmadni sebagai Pengarah Perhutanan bagi tempoh mulai 1 Oktober 2015 dibatalkan berkuat kuasa mulai 15 Ogos 2017.

## NATIONAL FORESTRY ACT 1984

APPOINTMENT AND REVOCATION OF APPOINTMENT OF DIRECTOR OF FORESTRY,  
DEPUTY DIRECTOR OF FORESTRY, ASSISTANT DIRECTOR OF FORESTRY  
AND FORESTER

IN exercise of the powers conferred by subsection 3(1) of the National Forestry Act 1984 [*Act 313*] and pursuant to the Fifth Schedule, the Minister has appointed the persons named in column (1) of the Schedule to hold the posts specified in column (2) for the Federal Territory of Kuala Lumpur with effect from the dates specified in column (3) and for the period they serve after such date with the Forestry Department of the Federal Territory of Kuala Lumpur.

**Revocation of appointment**

2. The appointment of Ag Shaffie bin Ag Ahmadni as a Director of Forestry for the period from 1 October 2015 is revoked with effect from 15 August 2017.
