AKTA KESELAMATAN SOSIAL PEKERJA 1969

PELANTIKAN AHLI LEMBAGA PERTUBUHAN KESELAMATAN SOSIAL

PADA menjalankan kuasa yang diberikan oleh seksyen 59B Akta Keselamatan Sosial Pekerja 1969 [Akta 4], Menteri telah melantik—

- (a) orang yang dinamakan dalam ruang (2) Jadual Pertama sebagai ahli Lembaga Pertubuhan Keselamatan Sosial di bawah peruntukan yang dinyatakan dalam ruang (1) dengan kedudukan sebagaimana dinyatakan dalam ruang (3) bagi tempoh yang dinyatakan dalam ruang (4); dan
- (b) orang yang dinamakan dalam ruang (3) Jadual Kedua sebagai ahli silih ganti bagi ahli Lembaga Pertubuhan Keselamatan Sosial yang dinamakan dalam ruang (2) di bawah peruntukan yang dinyatakan dalam ruang (1) bagi tempoh dari 21 Ogos 2017 hingga 31 Julai 2019.

EMPLOYEES' SOCIAL SECURITY ACT 1969

APPOINTMENT OF MEMBERS OF THE SOCIAL SECURITY ORGANIZATION BOARD

IN exercise of the powers conferred by section 59B of the Employees' Social Security Act 1969 [Act 4], the Minister has appointed—

- (a) the persons named in column (2) of the First Schedule as members of the Social Security Organization Board under the provisions specified in column (1) in the capacity as specified in column (3) for the period specified in column (4); and
- (b) the persons named in column (3) of the Second Schedule as the alternate members for the members of the Social Security Organization Board named in column (2) under the provisions specified in column (1) for the period from 21 August 2017 to 31 July 2019.
