FREE ZONES (AMENDMENT) (NO. 2) NOTIFICATION 2017

IN exercise of the powers conferred by subsection 10(2) of the Free Zones Act 1990 [*Act 438*], the Minister makes the following notification:

Citation and commencement

1. (1) This notification may be cited as the **Free Zones (Amendment) (No. 2) Notification 2017**.

(2) This Notification comes into operation on 15 September 2017.

2. The First Schedule to the Free Zones Act 1990 is amended in item 10 by inserting after the words "*Gazette* Plan 1207" the words "and *Gazette* Plan 1981".
