- (E) A point of the coast at Latitude 02° 17.50' North, Longitude 102° 05.20' East, and

returning to position (A) following the coast, including all rivers and tributaries flowing into these waters navigable by seagoing vessels and all piers, jetties, wharves, landing places, quays, docks and other similar works whether within or without the high-water mark and any portion of shore or bank within 45.72 meters of the high-water mark, subject to any rights of private property therein.”.

MERCHANT SHIPPING ORDINANCE 1952

DECLARATION OF ALTERATION OF PORT LIMITS FOR
KUALA SUNGAI LINGGI PORT

IN exercise of the powers conferred by subsection 6(3) of the Merchant Shipping Ordinance 1952 [*Ord. 70/1952*], the Minister alters the port limits for Kuala Sungai Linggi Port in the State of Malacca as defined in the Legal Notification No. 73 of 1953 [*L.N. 73/1953*].

Alteration of port limits

2. The Legal Notification No. 73 of 1953 is amended in the First Schedule, in respect of the State of Malacca, by substituting for item 46B the following item:

FIRST SCHEDULE

*State of Malacca**First column**Second column*

"46B. Kuala Sungai Linggi

The areas enclosed by the following imaginary lines:

- (A) From a point of the coast at Latitude 02° 24.40' North, Longitude 101° 51.20' East, directly to
- (B) Latitude 02° 23.00' North, Longitude 101° 50.30' East, to
- (C) Latitude 02° 14.70' North, Longitude 102° 01.60' East, to
- (D) Latitude 02° 16.50' North, Longitude 102° 04.30' East, to
- (E) A point of the coast at Latitude 02° 17.50' North, Longitude 102° 05.20' East, and returning to position (A) following the coast,

including all rivers and tributaries flowing into these waters navigable by seagoing vessels and all piers, jetties, wharves, landing places, quays, docks and other similar works whether within or without the high-water mark and any portion of shore or bank within 45.72 meters of the high-water mark, subject to any rights of private property therein.”.
