PELANTIKAN DAN PEMBATALAN PELANTIKAN ANGGOTA

PADA menjalankan kuasa yang diberikan oleh subseksyen 5(1) Akta Majlis Perundingan Gaji Negara 2011 [*Akta 732*], Menteri melantik Amir bin Omar sebagai anggota Majlis Perundingan Gaji Negara daripada kalangan pegawai awam yang mewakili Kementerian Sumber Manusia berkuat kuasa mulai 15 Mei 2017 hingga 30 September 2017.

**Pembatalan pelantikan**

## NATIONAL WAGES CONSULTATIVE COUNCIL ACT 2011

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBERS OF  
THE NATIONAL WAGES CONSULTATIVE COUNCIL

IN exercise of the powers conferred by subsection 5(1) of the National Wages Consultative Council Act 2011 [*Act 732*], the Minister appoints Amir bin Omar as a member of the National Wages Consultative Council from amongst public officers representing the Ministry of Human Resources with effect from 15 May 2017 to 30 September 2017.

(B) 387/2015] on 30 September 2015 is revoked with effect from 14 May 2017.
