CHILD ACT 2001

APPOINTMENT AND REVOCATION OF APPOINTMENT OF HENRY GURNEY SCHOOL

IN exercise of the powers conferred by section 73 of the Child Act 2001 [Act 611], the Minister appoints the area and all buildings surrounded by chain-link fences situated on Lot 103 and Lot 135311787, Mukim Kindasan, District of Keningau, Sabah and designated as “Henry Gurney School, Keningau, Sabah” to be a Henry Gurney School for the purposes of this Act, with effect from 31 March 2017.

Revocation

2. The Appointment of Second Henry Gurney School, Keningau, Sabah [P.U. (B) 366/1991] published on 18 July 1991 is revoked with effect from 31 March 2017.
