STAMP ACT 1949

APPOINTMENT OF DEPUTY COLLECTOR OF STAMP DUTIES

IN exercise of the powers conferred by subsection 3(2) of the Stamp Act 1949 [*Act 378*], the Minister appoints the officers specified in column (2) of the Schedule as Deputy Collector of Stamp Duties for the purpose of carrying out the provisions of the Act for the area specified in column (1) with effect from the date specified in column (3).
