PADA menjalankan kuasa yang diberikan oleh perenggan 5(1)(e) Akta Majlis Perundingan Gaji Negara 2011 [*Akta 732*], Menteri melantik orang yang dinamakan dalam Jadual Pertama sebagai anggota Majlis Perundingan Gaji Negara yang mewakili pekerja bagi tempoh dari 1 Januari 2017 hingga 30 September 2017.

(B) 126/2016*] yang disiarkan dalam *Warta* pada 25 Mac 2016 dibatalkan berkuat kuasa mulai 1 Januari 2017.

NATIONAL WAGES CONSULTATIVE COUNCIL ACT 2011

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBERS OF
THE NATIONAL WAGES CONSULTATIVE COUNCIL

IN exercise of the powers conferred by paragraph 5(1)(e) of the National Wages Consultative Council Act 2011 [*Act 732*], the Minister appoints the persons named in the First Schedule as members of the National Wages Consultative Council representing the employees for the period from 1 January 2017 to 30 September 2017.

Revocation of appointment

2. The appointment of the persons named in the Second Schedule as members of the National Wages Consultative Council representing the employees in the notification of Appointment of Members of the National Wages Consultative Council [*P.U. (B) 387/2015*] published in the *Gazette* on 30 September 2015 and the notification

of Appointment and Revocation of Appointment of Members of the National Wages Consultative Council [*P.U. (B) 126/2016*] published in the *Gazette* on 25 March 2016 is revoked with effect from 1 January 2017.
