ESTATE DUTY ENACTMENT 1941

APPOINTMENT AND REVOCATION OF APPOINTMENT OF ASSISTANT COLLECTOR OF
ESTATE DUTY

IN exercise of the powers conferred by section 52 of the Estate Duty Enactment 1941, and read together with subsection 46(2) of the Finance Act 1992 [*Act 476*], the Yang di-Pertuan Agong has appointed the persons named in the First Schedule to be the Assistant Collector of Estate Duty for the purpose of carrying out the provisions of the Enactment with effect from 1 April 2016.

Revocation

2. The appointment of the persons named in column (1) as published in the *Gazette* in column (2) of the Second Schedule is revoked with effect from 1 April 2016.
