Kekosongan jawatan

1. Jawatan yang akan menjadi kosong pada 14 Ogos 2016 adalah bagi sembilan pengamal perubatan berdaftar penuh yang bermastautin di Semenanjung Malaysia yang hendaklah dipilih oleh pengamal-pengamal perubatan berdaftar penuh yang bermastautin di Semenanjung Malaysia.

Penamaan calon

2. (1) Penamaan calon untuk jawatan yang akan menjadi kosong itu dipohon.

(2) Borang penamaan (Borang 1) boleh diperoleh di pejabat Pengarah Kesihatan Negeri yang berkenaan di Semenanjung Malaysia atau daripada Setiausaha, Majlis Perubatan Malaysia, Kementerian Kesihatan Malaysia, Aras Bawah, Blok B, Jalan Cenderasari, 50590 Kuala Lumpur atau boleh dimuat turun daripada laman web Majlis di www.mmc.gov.my.

NOTICE OF VACANCY OF ELECTED OFFICE IN THE MALAYSIAN MEDICAL COUNCIL

PURSUANT to paragraph 4(1)(b) of the Medical Regulations 1974 [*P.U.(A) 68/1974*], notice is given for the vacancy of elected office in the Malaysian Medical Council as follows:

Vacancy

1. The offices that will fall vacant on 14 August 2016 are for nine fully registered medical practitioners resident in Peninsular Malaysia to be elected by the fully registered medical practitioners resident in Peninsular Malaysia.

Nomination of candidate

2. (1) Nomination of candidates to the offices that will fall vacant is requested.
