PELANTIKAN PENERUS SUATU BAHAGIAN MAHKAMAH PERUSAHAAN

PADA menjalankan kuasa yang diberikan oleh subseksyen 23(2) Akta Perhubungan Perusahaan 1967 [*Akta 177*], Yang di-Pertuan Agong melantik –

- (a) orang yang dinamakan dalam Jadual Pertama sebagai Pengerusi suatu Bahagian Mahkamah Perusahaan berkuat kuasa mulai 1 April 2009; dan
- (b) orang yang dinamakan dalam Jadual Kedua sebagai Pengerusi suatu Bahagian Mahkamah Perusahaan bagi tempoh mulai 1 Mac 2015 hingga 31 Ogos 2015.

INDUSTRIAL RELATIONS ACT 1967

APPOINTMENT OF CHAIRMAN OF A DIVISION OF THE INDUSTRIAL COURT

IN exercise of the powers conferred by subsection 23(2) of the Industrial Relations Act 1967 [*Act 177*], the Yang di-Pertuan Agong appoints –

- (a) the persons named in the First Schedule as the Chairman of a Division of the Industrial Court with effect from 1 April 2009; and
- (b) the persons named in the Second Schedule as the Chairman of a Division of the Industrial Court for the period from 1 March 2015 to 31 August 2015.
