NOTICE OF EXTENSION OF TIME PERIOD FOR MAKING PRELIMINARY
DETERMINATION

(AD 02/15)

FOLLOWING the publication of the Notice of Initiation of an Anti-Dumping Duty Investigation with regard to the Imports of Prepainted, Painted or Colour Coated Steel Coils Originating or Exported from the People's Republic of China and Socialist Republic of Viet Nam in P.U. (B) 207/2015 on 28 April 2015, the Government extends the time period by an additional thirty days from 27 August 2015 until 25 September 2015 for making the preliminary determination pursuant to subregulation 10(2) of the Countervailing and Anti-Dumping Duties Regulations 1994 [*P.U. (A) 233/1994*] in the case of anti-dumping duty investigation with regard to the imports of prepainted, painted or colour coated steel coils originating or exported from the People's Republic of China and Socialist Republic of Viet Nam.
