PELANTIKAN NOTARI AWAM

NOTARIES PUBLIC ACT 1959

APPOINTMENT OF NOTARY PUBLIC

IN exercise of the powers conferred by subsection 3(1) of the Notaries Public Act 1959 [*Act 115*], the Attorney General has appointed the advocates and solicitors named in column (1) of the Schedule to be notaries public to practise at the places specified in column (2) for a period of two years with effect from the dates specified in column (3).
