FREE ZONES REGULATIONS 1991

NOTICE OF PUBLIC AUCTION UNDER PARAGRAPH 34(2)(b)

PURSUANT to paragraph 34(2)(b) of the Free Zones Regulations 1991 [P.U. (A) 321/1991], notice is given that a public auction will be held on a date to be fixed after thirty days from the date of the publication of this Notice in the *Gazette* to dispose of any goods, other than perishable or inflammable goods, which have been brought into the free zone of the Port of Tanjung Pelepas, Johor and—
