## PERISYTIHARAN PENGUBAHAN HAD PELABUHAN BAGI PELABUHAN LUMUT

## MERCHANT SHIPPING ORDINANCE 1952

## DECLARATION OF ALTERATION OF PORT LIMITS FOR LUMUT PORT

IN exercise of the powers conferred by subsection 6(3) of the Merchant Shipping Ordinance 1952 [*Ord. 70/1952*], the Minister alters the port limits for Lumut Port in the State of Perak as defined in the Legal Notification No. 73 of 1953 [*L.N. 73/1953*].

**Alteration of port limits**

2. The Legal Notification No. 73 of 1953 is amended in the First Schedule, in respect of the State of Perak—

(a) by substituting for item 64 the following item:

(D) Latitude 04° 06' North, Longitude 100° 45.45' East, and returning to position (A), including all other navigable rivers and tributaries flowing into these waters and all piers, jetties, wharves, landing places, quays, docks and other similar works within or without the high-water mark and any portion of shore or bank within 45.72 meters of the high-water mark subject to any rights of private property therein.”; and

(b) by deleting item 72.
