NOTICE OF COMPLETION OF ASSUMPTION OF CONTROL

WHEREAS, by the Co-operative Societies (Assumption of Control) Order 2012 [*P.U. (A) 12/2012*] published on 13 January 2012, the Malaysia Co-operative Societies Commission has appointed Nooh bin Tokio to assume control of the whole of the property, business, activities and affairs of the Koperasi Kemajuan Tanah Negeri Johor Berhad and its related corporations, and carry on the whole of its business, activities and affairs:
