COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

NOTICE OF TERMINATION OF AN ANTI-DUMPING DUTY INVESTIGATION WITH
REGARD TO IMPORTS OF NEWSPRINT IN ROLLS ORIGINATING OR EXPORTED FROM
BELGIUM, FEDERAL REPUBLIC OF GERMANY, SWEDEN AND UNITED KINGDOM

(AD 02/13)

PURSUANT to paragraph 26(1)(e) of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504], the Government of Malaysia has determined that termination of the investigation with regard to imports of newsprint in rolls, classified under Harmonized System Code (H.S. Code) Number 4801.00.100 ("subject merchandise") originating or exported from Belgium, Federal Republic of Germany, Sweden and United Kingdom is in the public interest.

Reason for determination

2. Pursuant to paragraph 26(1)(e) of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504] the Government shall, with immediate effect, terminate the investigation in relation to subject merchandise exported from Belgium, Federal Republic of Germany, Sweden and United Kingdom based on the determination made for public interest .
