HOUSING DEVELOPMENT (CONTROL AND LICENSING) ACT 1966

EXEMPTION UNDER SUBSECTION 2(2)

IN exercise of the powers conferred by subsection 2(2) of the Housing Development (Control and Licensing) Act 1966 [*Act 118*], the Minister exempts Sendi Bangga Development Sdn. Bhd. from all of the provisions of the Act in relation to the development on Lot 20926 (P.T.11921) H.S.(D) 48924, Mukim Damansara, Daerah Petaling, Selangor Darul Ehsan for one (1) block of Small Office Home Office (SOHO) consisting of 448 units of housing accommodation only with effect from 12 April 2007 until the Certificate of Fitness for Occupation (CFO) is issued.
