- (A) substitute for the word “28,667” appearing against item A the word “28,687”; and
  - (B) substitute for the word “2,273” appearing against item G the word “2,577”; and
- (vi) for the Constituency of N. 22 Manir, substitute for the words “91.16%” appearing against item F the words “91.2%”.
