COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

NOTICE OF TERMINATION OF AN ANTI-DUMPING DUTY INVESTIGATION  
WITH REGARD TO IMPORTS OF HOT ROLLED COILS ORIGINATING OR EXPORTED  
FROM CHINESE TAIPEI

(AD 02/12)

PURSUANT to subsection 26(1)(a) of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*], the Government of Malaysia has received a letter from the petitioner informing the Government of Malaysia that the petitioner withdraws its petition on imports of hot rolled coils under Harmonised System Code (H.S. Code) Number 7208.36.000, 7208.37.000, 7208.38.000, 7208.39.100, 7208.39.910 and 7208.39.990 (“subject merchandise”) originating or exported from Chinese Taipei.

**Termination of investigation**

2. Pursuant to subsection 26(1)(a) of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] the Government shall, with immediate effect, terminate the investigation in relation to the subject merchandise exported from Chinese Taipei based on the withdrawal by the Petitioner.
