IN exercise of the powers conferred by subregulation 10(2) of the Countervailing and Anti-Dumping Duties Regulations 1994 [*P.U. (A) 233/1994*], in relation to *P.U. (B) 248/2012* the Government has granted an extension of time in relation to the period for making the preliminary determination in the case of anti-dumping duty investigation with regard to the importation of biaxially oriented polypropylene films originating or exported from Chinese Taipei, the Kingdom of Thailand, the People's Republic of China, the Republic of Indonesia and the Socialist Republic of Viet Nam from 24 November 2012 to 23 December 2012.
