## DELEGATION OF POWERS ACT 1956

DELEGATION OF POWERS UNDER SECTIONS 77, 84 AND 85  
OF THE ROAD TRANSPORT ACT 1987

IN exercise of the powers conferred by section 5 of the Delegation of Powers Act 1956 [Act 358], the Minister delegates his powers under sections 77, 84 and 85 of the Road Transport Act 1987 [Act 333], in respect of Federal roads to the officers specified in column (1) of the Schedule for the areas specified in column (2).

**Revocation**

2. (1) Delegation of powers under section 77 of Road Transport Act 1987 for State of Sabah which is made in P.U. (B) 42/96 which was published on 1 February 1996 is revoked.

(2) Delegation of powers under section 84 of Road Transport Act 1987 for State of Sabah which is made in P.U. (B) 43/96 which was published on 1 February 1996 is revoked.

(3) Delegation of powers under section 85 of Road Transport Act 1987 for State of Sabah which is made in P.U. (B) 44/96 which was published on 1 February 1996 is revoked.
