NATIONAL WAGES CONSULTATIVE COUNCIL ACT 2011

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBERS OF
THE NATIONAL WAGES CONSULTATIVE COUNCIL

IN exercise of the powers conferred by subsection 5(1) of the National Wages Consultative Council Act 2011 [*Act 732*], the Minister appoints the persons named in the column (1) of the First Schedule as members of the National Wages Consultative Council representing government agencies for the period as specified in column (2).

Revocation of appointment

2. The appointment of persons named in column (1) of the Second Schedule as members of the National Wages Consultative Council representing government agencies published in P.U. (B) 586/2011 on 25 November 2011 is revoked with effect from the date as specified in column (2).
