CONTROL OF PADI AND RICE ACT 1994

APPOINTMENT AND REVOCATION OF APPOINTMENT OF THE DIRECTOR GENERAL
FOR THE CONTROL OF PADI AND RICE

IN exercise of the powers conferred by subsection 3(1) of the Control of Padi and Rice Act 1994 [*Act 522*], the Minister appoints Datin Naimah binti Ramli to be the Director General for the control of padi and rice for the purpose of carrying out the duties and functions assigned to her under the Act with effect from 1 May 2012.
